Mike,

As you can see from the email chain attached, Jim White has posted photos of me on a Facebook page he launched yesterday. He posted these pictures without my knowledge or permission and they remain posted despite my repeated requests to the contrary. More disturbing to me was that I am identified by name and title as Chairman of the Upper Providence Board of Supervisors, but I was not tagged, nor invited to like the page, which indicates to me that this was a stealth attempt by Jim to hijack my name and reputation in service to his campaign to become UPT supervisor--a campaign that is premature, at best. Indeed, the only reason I even know about this is because Meredith Keleman invited me to like the page. Jim himself did not.

Your picture also appears on this site along with Warren's and Ryan Costello's, however you are the only one who is tagged. I found this surprising since when I ran for supervisor, you supported my campaign privately, but told me that you made it a policy never to lend your image or your support publicly in your district since you would have to work with whomever was elected.

I know Jim has indicated to Don that he will not run if he is not endorsed, which is why I think the Facebook page is premature. He needs to win the support of the committee before he begins to try and win the support of the voters. A Facebook campaign page launched before the endorsement meeting seems to fly in the face of what Jim has represented to Don.

I think you should also be aware that it has reached my ears that a campaign has begun to make Upper Providence a 5 member board and that Jim is spearheading this effort with your blessing. I hope that this rumor is not true; Upper Providence is a well run township that does not suffer from the infighting and factionalization that our neighbors with five member boards do. Nothing will open the door wider for Democrats than a five member board.

Mike, as you know, I feel it is my duty to alert you to potentially troublesome issues regarding Upper Providence Township. Jim's posting of my pictures and the rumors of agitation for a five member board are troubling and indicative of a candidate who has placed his own wants and desires above those of the Township and the Party.

As much as it galls me to "run to daddy" with this, clearly, Jim has no respect for me or my hard won position in the Township. As you felt compelled to come to Don, Doug and I to lobby for Jim in having the committee not endorse, I feel compelled to come to you now to let you know exactly where I stand with this. I have taken the liberty of copying both Jim and Don on this email so there can be no misunderstandings. This situation is unacceptable and I am furious about Jim's blatant disregard of my wishes regarding the use of my name and likeness and the news of a five member board. Thank you for your email. Let me address the issues you raised and if I miss one it's not intentional it's just that I am doing this from a mtg on my phone.

Having this conflict between them is not helpful either of us as reps and certainly not what I want to be involved in and won't be involved in as chairman. I have instructed Jim to not use photos of Warren and I on mail or palm cards if he were to do such a thing.

I truly see fb differently. And while you will disagree and may do so with warrant, my photos are tagged by over 7,800 people including those that ran for state committee and other offices in this region.

Let me take the remainder of this day to think this out. But let me be clear that my only involvement in this is to try to avoid a war in your township in our party and in part of my district. And for the record Al is a constituent.

As for the 5 member board, I asked if u would consider it and maybe we could ask jim to run when that happens. I have not and will not endorse or participate in any movement or lack thereof with anyone about this issue because it's none of my business. I saw it as a potential solution.

I am glad we did this group email and perhaps we should have had al on it as well. Jim and Al are Both friends and I have know al for over 20 yrs. In the short time I have known Jim he has been nothing but supportive financially and has opened his house for republican candidates. It's hard to pick a winner or loser in this.

Mike, I respectfully disagree in the strongest possible terms about the Facebook pictures. As I said to Jim, they are in the public domain, however, they were never posted on a *campaign* page. When I left WFYL two years ago, I had to send a cease and desist letter to them to take my name and image off of their website because I did not want to be associated with the tinfoil hattery of the new owners. You may not have a problem with your pictures up there promoting a candidacy, but I definitely do and would hope that my wishes would be respected. Apparently since Jim has your blessing for your pictures, he doesn't feel like he needs mine. I do not want to contact counsel for another cease and desist letter, but I will if I have to. It's my reputation, my image. I think I should have a say in how it is used, especially by people who are supposed to be on my team.

What really grinds my gears about the pictures is the stealth way they were posted, without tagging me, or inviting me to like the page. It's almost as if he wanted to mislead people into thinking it was an endorsement without me even getting a say.

Regarding the five member board: you know and understand my feelings on this. I firmly believe it would destroy our township. Period.

Finally, at your suggestion I have copied Al in on this thread. Al has indicated to me that he will not run if he is not endorsed. I believe this, because Al and his family have been around Montgomery county politics all their lives and they know that no good comes from republican civil wars. So there is only one threat of a bloodbath in my township and that's the candidate who says he's running regardless of the endorsement.

It goes without saying that whoever wins this election will have to sit with me for at least two years. It's insulting that my simple little request to remove the pictures--'for a reason you have given yourself in the past Mike---is being blatantly disregarded.

I am not the one being unreasonable and peace in Upper Providence is only being threatened by one person at this point.
